

2009 TRUSSME NATIONAL CAPITAL RALLY

The 2009 National Capital Rally is promoted by the Brindabella Motor Sport Club (BMSC.)
 The BMSC is a local car club involved in all levels of rallying within the ACT and surrounding region. Our club members compete at all levels including the Australian, and State Championships. This event is the final round of the NSW State Championship, and our own PCD Engineering ACT Regional Rally Series.

FIRST CAR DUE AT SPECTATOR POINT:

Start: In staging area from 10:30am, Start at 11:30
Spec 1: Castrol Corner: 11:40 pm
Spec 2: Old Kowen Rd: 12:40pm and again at 2:20pm
Service: From 1:00pm until 7:00pm
Spec 3: Blue Tiles: 15:25pm and again at 4:55pm
Spec 4: Castrol Corner: 7:30pm
Finish Venue: 7:45pm

SPECTATOR POINT - RALLY START

Car 1 will start at 11:30am
 Cars will depart from the Weston Club – Liardet St Weston.

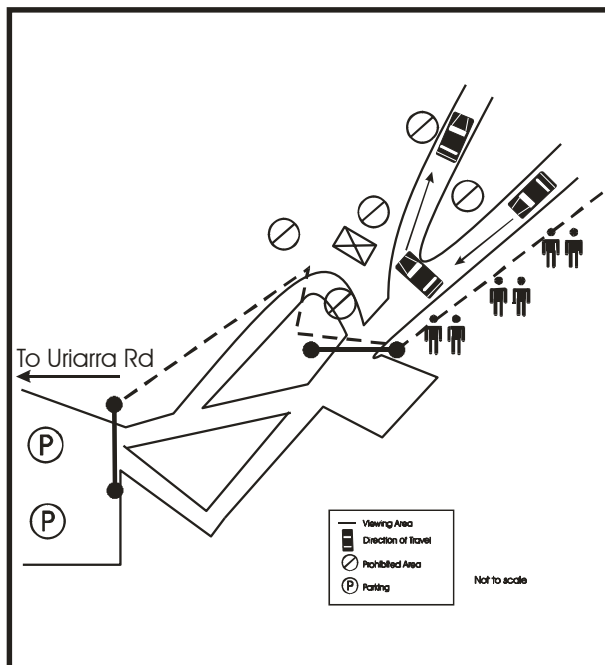
FROM WESTON CLUB TO SPECTATOR POINT TO 1

- From the start Turn Left onto Liardet St and then the road goes left (in front of Macca's), Turn Left onto Namatjira Dr.
- Turn Right onto Streeton Dr and at the traffic lights turn left towards the Cotter.
- Follow Cotter Rd for 2.5 km Turn Right onto Uriarra Rd,
- Turn Right into the carpark

SPECTATOR POINT 1 "Castrol Corner"

Car 1 Due 11:40pm and again at 7:30 pm

A classic from yesteryear, a fast approach into a Turn Very Hard Right, Hard to See, there is bound to be some dust thrown around here



FROM SPECTATOR POINT 1 TO SERVICE PARK

- Return to Uriarra Rd and turn Left, then Right onto Cotter Rd, then in 300m Turn Left onto Eucumbene Dr
- Follow for approx 2 km then the road goes left, this is Hindmarsh Dr, Follow through numerous sets of lights for approx 14.2km
- Turn right onto Canberra Ave (DFO on corner) towards Queanbeyan
- Follow Canberra Ave for approx 2.7 km then keep left onto Norse Rd after approx 800m turn Left
- At the traffic lights turn Left and follow to end where you turn Right.
- Follow Pialago Ave for 700m and turn Left onto Sutton Rd. After approx 1.3km turn Right onto Kowen Rd, this is a narrow road and has 2 way traffic and is 40km/h, please be careful.
- When the bitumen ends keep Left (spectator point 3 is on the Right)
- Follow Kowen Rd for about 5 km and the service park is on the Right.

Toilet Facilities are available at the Service Park.

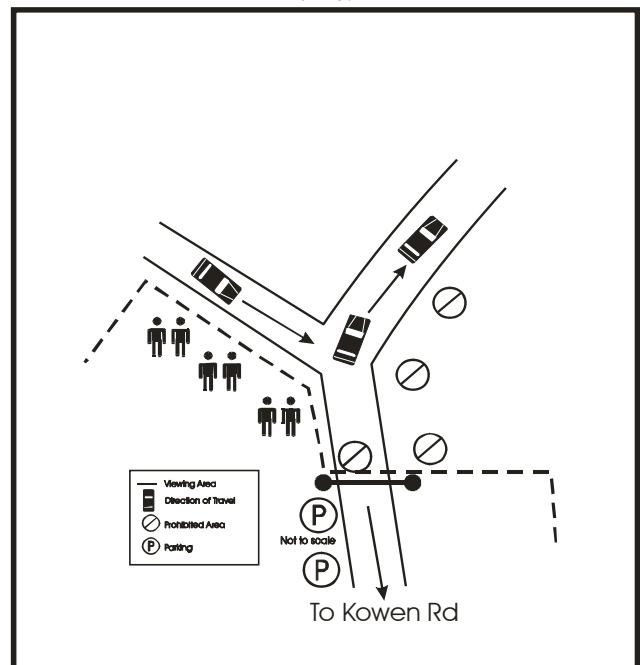
FROM SERVICE PARK SPECTATOR POINT 2

- Return to Kowen Rd and after 700m you will see signs to spectator point 2 on the Right
 Please park in the area on the Left of the road.

SPECTATOR POINT 2 "Old Kowen Road"

Car 1 Due 12:40pm and again at 2:20pm

A turn left at TJ, with the crews having come over a series of humps and dips, now that they are on a straight approach to the TL they will be trying to claw back a bit of time.

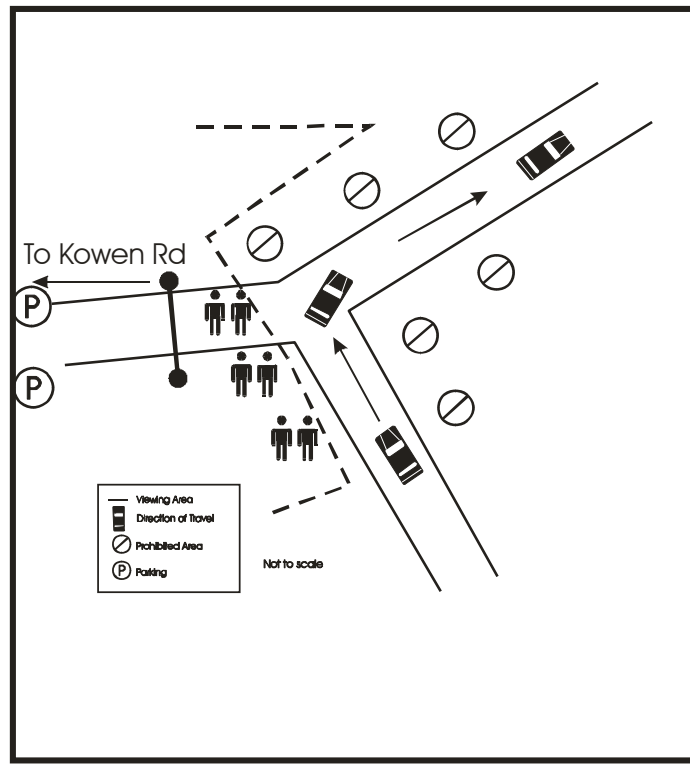


FROM SPECTATOR POINT 2 TO SPECTATOR POINT 3

- Return to Kowen Rd and turn Right, just before the road become bitumen turn very hard Left
Please park as far off the road as you can on the left

SPECTATOR POINT 3 "Blue Tiles" Car 1 Due 15:25pm and again at 4:55pm

A "Turn Right at TJ" After a long drag uphill the crews will approach this with some speed and attitude, watch the concrete obstacle if a car should overshoot.



RETURN TO FINISH VENUE AND PRESENTATION.

- From spectator areas return to Kowen Rd and proceed onto the bitumen, remember this is 2 way and 40km/h through the gate and then turn Right at the end onto Sutton Rd
- Follow to the end again and turn Right onto Pialago Ave, after 600m turn Left onto Oakes Estate Rd and follow this to the end
- Turn Right at the traffic lights and again follow to the end where you turn Right, follow Canberra Ave for about 3.5km and turn Left onto Hindmarsh Dr (DFO on Right) at the traffic lights.
- Follow Hindmarsh drive all the way through those traffic lights to the end where the road goes Right.
- Follow Eucumbene Dr to the end and turn Right onto Cotter Rd, then 300m turn Left onto Uriarra Rd and then Right into the spectator point.

This is the end of forest spectating for today, the service area will still be the scene of frantic action and well worth another visit.

RETURN TO FINISH VENUE AND PRESENTATION.

- From Spectator Point 4, return to Uriarra Road and Turn Left
- At the traffic lights Turn Right onto Stretton drive follow for 1.25km and Turn Left onto Namatjira Dr
- Turn right in front of Macca's Liardet St and follow till you get to the Club where it all started this morning.
